<b>Effective Date</b>	January 1, 2025	
<b>Eligibility</b>	All active full-time Salaried Academic, Unclassified and Classified Employees working at 75% full-time employment or greater who are paid and appointed to a position for more than 120 days or one regular academic semester, excluding the Health Sciences Center employees who have coverage through the Office of Graduate Medical Education,	
<b>Class Description</b>	All eligible active employees who enrolled in LTD coverage on or after 1/1/01 and; all eligible active employees who were enrolled for LTD coverage prior to 1/1/01, and then elected to switch coverage to this plan.	
<b>Voluntary LTD Benefit</b>	60.0% of your Monthly Earnings to a maximum of \$12,000 per month.  Minimum Benefit: Greater of \$100 or 10% of gross monthly benefit  Guaranteed Issue Benefit: \$12,000  Earnings are defined in the UnitedHealthcare contract with your employer.	
<b>Elimination Period</b>	The later of: 90 days of Disability or the exhaustion of Accumulated Sick Leave	
<b>Definition of Disability</b>	Residual	
<b>Own Occupation Period</b>	24 months (2 year) own occupation

<b>Other limitations to enrollment</b>	<p>You must be Actively at Work with your employer on the day your coverage takes effect.</p> <p>Evidence of Insurability is required for all late entrants</p> <p>This coverage, like most group benefit Insurance, requires that a certain percentage of eligible employees participate. If that group participation minimum is not met, the insurance coverage that you have elected may not be in effect.</p>

It in no way changes or affects the policy as actually issued.** Only the insurance policy issued to the policyholder (your employer) can fully describe all of the provisions, terms, conditions, limitations and exclusions of your insurance coverage. In the event of any difference between the Summary of Benefits sheet and the insurance policy, the terms of the insurance policy apply.

### Limitations and Exclusions:

You cannot receive Long Term Disability Insurance benefit payments for disabilities that are caused or contributed to by\*:

- War or act of war (declared or not)
- The commission of, or attempt to commit a felony
- An intentionally self-inflicted injury
- Any case where your being engaged in an illegal occupation was a contributing cause to your disability

You must be under the regular care of a physician to receive benefits.\*

Your benefit payments **will be reduced** by other income you receive or are eligible to receive due to your disability, including but not limited to\*:

- Social Security Disability Insurance (please see next section for exceptions) and/or LASERS and TRSL
- Workers' Compensation
- Other employer-based insurance coverage you may have
- Unemployment benefits
- Settlements or judgments for income loss
- Retirement benefits that your employer fully or partially pays for (such as a pension plan)
- Loss of time or lost wages from a no-fault motor vehicle insurance plan.
- Benefits from Employer's sick leave or salary continuation plan.

Your benefit payments **will not be reduced** by certain kinds of other income, such as\*:

- Retirement benefits if you were already receiving them before you became disabled
- Retirement benefits that are funded by your after-tax contributions
- Your personal savings, investments, IRAs or Keoghs
- Profit-sharing
- Most personal disability policies
- Social Security increases

*\*Some State variations may apply.*
